RESOLUTION TO APPROVE GREAT WEST ENGINEERING AS THE FLOOD PLAIN ADMINISTRATOR, AMENDMENT NO. 2 TO TASK ORDER NO. 6

WHEREAS; the Town of Twin Bridges, Montana, is required to have a floodplain administrator per the Floodplain Ordinance of the Town of Twin Bridges.

WHEREAS; the Town of Twin Bridges has requested Great West Engineering to act on their behalf as the Floodplain Administrator.

WHEREAS; the amendment number 1 to Task Order No. 6 (On Call Engineering Services) with Great West Engineering is ending on June 30, 2021. The Town of Twin Bridges is renewing contract through June 30, 2022.

NOW THEREFORE IT BE RESOLVED by the Town Council that Amendment No. 2 for Task Order No. 6 (On Call Engineering Services) received from Great West Engineering, Inc. is acceptable and the Town of Twin Bridges will use Great West Engineering, Inc. for on-call floodplain administration not to exceed \$2,000 in cost.


