

Resolution 2021-14

A Resolution Cancelling the November 2, 2021 General Election of Certain Municipal Officers

WHEREAS, HB 447 passed by the 2017 Legislature (Chapter 174, Laws 2017) authorizes a municipality to cancel a general election for the election of a municipal officer by resolution after notification by the election administrator if the number of candidates filing for election is equal or less than the number of persons to be filled; and

WHEREAS, by email dated September 3, 2021, the Town of Twin Bridges received notice by the Madison County Election Administrator that the following elected officer positions are eligible for cancellation Mayor and four (4) council person seats; and

WHEREAS, pursuant to Section 13-1-403, as amended by HB 83 (Chapter 242, Laws 2017), provides that a declaration of intent to be a write-in candidate must be filed with the election administrator by 5 pm on the 65th day before the date of the election, or August 31, 2021;

WHEREAS, on July 13, 2021, the Town of Twin Bridges passed a Resolution of Notice of Intent to cancel the municipal officer positions set forth herein if they remained uncontested as of August 31, 2021; and


WHEREAS, as of August 31, 2021, the following municipal officer positions remain eligible for cancellation: Mayor and four (4) council persons.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Town of Twin Bridges cancels the November 2, 2021, general election for the following municipal officer positions: Mayor and four (4) council persons.
2. The following persons are hereby elected to the following municipal officer positions by acclamation:

Mayor	No Candidate Running – Vacant Seat
Council Person	Matt Greemore (4-year term)
Council Person	Nolan Frandsen (4-year term)
Council Person	James "JB" Klyap (4-year term)
Council Person	Jordan High (2-year remainder of term – appointed to position)


